4 Admission Categories for M.Tech

Following are the three categories under which a candidate can apply depending upon his/her eligibility. Qualifying in GATE is not mandatory.

4.1 M.Tech (Full-Time) Category (2 Years)

(i) Graduates with B.E/B.Tech. degree (GATE/Non-GATE candidates)

4.2 M.Tech (Sponsored) Category (2 Years)

- (i) Any student seeking admission under this category shall be working on a regular post in any Government/semi government/public/private sector (units/industries/ academic institutes/ research organizations/ Architectural firm) for a minimum period of two years at the time of admission.
- (ii) The application form of such candidates should be duly forwarded by the parent organizations and should record that the candidate will be allowed to attend the classes in day time and will be allowed to stay in the campus/ Jamshedpur during his/ her PG programme duration.
- (iii) There will be NO concessions on fee to be deposited in NIT Jamshedpur.
- (iv) No financial liability will be on the part of the NIT Jamshedpur.

4.3 M.Tech (Part-Time) Category (3 Years)

- (i) Institute also offers Part-time Post Graduate Programme towards M. Tech. degree for employed/self-employed graduates who reside nearby Jamshedpur.
- (ii) The eligibility criteria for admission to part-time programme shall be the same as that for sponsored students.
- (iii) Part-time students are not eligible for assistantships.
- (iv) The classes for part-time students will be held in the evening hours and the schedule will be notified by the concerned department.
- (v) The minimum period for completion of course work and thesis duration shall be three years from the date of registration. The maximum period shall be five years.
- (vi) Other Regulations as applicable to regular students, except residency requirements, shall also be applicable to part-time students.

5 Admission Procedure

- Application form is required to be submitted, which will remain available on the website https://online.nitjsr.ac.in/mtech2024
- Non-refundable application processing fee of Rs. 1000/- for Gen, OBC-NCL & EWS and Rs. 500/- for SC, ST & PwD. Link for payment will be available on <u>https://online.nitjsr.ac.in/mtech2024</u>.
- The scanned copies of supporting documents/testimonials/certificates are required to be uploaded through online application portal. Candidates willing to apply for more than one programme need to apply separately for each programme.
- List of applicants shortlisted for further participation in the selection process such as written-test and Interview will be displayed on the Institute website. No separate communication/intimation in this regard shall be made by the Institute. The date and

time of written-test and/or Interview will be informed only through the Institute website.

- It is the responsibility of the candidate, to ensure that he/she satisfies all eligibility criteria for a particular programme, as mentioned in this information brochure.
- The following documents need to be uploaded along with M.Tech application form
 - Recent passport size photograph.
 - 10th and 12th Mark sheet and certificate
 - Qualifying Degree Marks-Sheet of final semester / final year (7th semester / prefinal year marks-sheet for the 'appearing candidates' whose final semester final year results are pending).
 - Valid GATE score card (for GATE- candidates only)
 - Caste certificate/EWS income certificate to avail seat reservation under respective reserved category. The OBC (NCL) and EWS certificate shall be as per CCMT format and issued on or after April 01, 2024.
 - Persons with Disabilities (PwD) persons are required to submit valid UDID card or a certificate of disability from the authorized medical board attached to one of the following - Vocational Rehabilitation Centre (VRC) for Physically Handicapped persons/ Special Employment Exchange for Physically Handicapped/ Government Hospital (District and State level).
 - Experience certificate and No Objection Certificate from the present employer (for sponsored and Part-Time candidates).
- The candidate needs to report at NIT Jamshedpur on the scheduled date, time and venue for appearing the written test and interview. If the candidate fails to report at the test/admission venue along with the requisite documents in original by that date and time, he/she will not be considered afterwards for admission.
- In addition to original copy of above mentioned documents following documents must be produced by the selected candidates at the time of reporting/joining to complete his/her Admission:
 - Copy of Admission fee payment receipt.
 - The Migration Certificate, College Leaving Certificate and Character Certificate.
 - Medical fitness certificate.
 - 2 passport size colour photographs.
 - Certificate for degree equivalence (if applicable).
 - The documents of the candidates will be verified by NIT Jamshedpur officials. Admission of only those candidates, whose documents are found in order and verified as satisfactory, will be confirmed.
 - All other formalities related to identity card and bank account, etc. will be completed subsequently by the candidate.

6 Eligibility Criteria

6.1 Eligibility Criteria for M.Tech (Full-Time) Category

The minimum academic eligibility criteria for M.Tech (Full-Time) category shall remain same as prescribed in CCMT 2024 (except GATE qualification). Admission under this category shall follow the guidelines set by CCMT 2024 in regard to preparation of merit list, allotment of seats, reservation rules, etc. Graduated students or final semester students in result awaited (RA) category are also eligible to apply.

6.2 Eligibility Criteria for M.Des.

- Four years bachelor's degree in any stream of Engineering, Design, Architecture, Fine Arts, or Economics.
- Master's degree in Science, Arts, Commerce, or Computer Application.

6.3 Eligibility Criteria for M.Tech (Sponsored) and M.Tech (Part-Time) Category

- Minimum academic eligibility criteria as prescribed in CCMT 2024 (except GATE qualification)
- The candidates with minimum two years of experience in any Government/semi government/public/private sector (units/industries/ academic institutes/ research organizations/ Architectural firm) with required qualification and having No Objection Certificates (NOC) from the employer

7 Financial Assistance

- The Financial assistance will be offered as per norms to the eligible GATE qualified candidates only.
- The Financial assistance may be offered as per norms to the eligible CEED qualified candidates only for M.Des. Programme.
- Sponsored, Non-GATE and Part-Time candidates are NOT eligible for any financial assistantships.

8 Reservation of Seats

- For all M. Tech categories (Full-Time, Part-Time and Sponsored), reservations norms will be followed as per the GoI.
- Reservation for SC/ST/OBC (Non-Creamy Layer)/EWS/PwD candidates will be as per the guidelines of Government of India.
- Form of OBC (Non-Creamy Layer) Certificate as per CCMT 2024 format must be produced by OBC (Non-Creamy Layer) candidates and should be issued on or after April 01, 2024.
- EWS Certificate as per CCMT 2024 format must be produced by EWS category candidates and should be issued on or after April 01, 2024.

9 Selection Process

• Institute Admission Test (IAT) is exempted for GATE qualified candidates only.

- CEED qualified candidates are exempted from the Institute Admission Test (IAT) for admission to M.Des. Programme.
- All Non-GATE, Sponsored and Part-Time candidates have to appear in Institute Admission Test (IAT). The IAT qualified candidates only will be called for interview on the same date of written test.
- No TA/DA will be paid for attending the IAT and Interview.

11 Medical Fitness

- Candidates must be in good health. A candidate is required to submit a medical certificate at the time of reporting at NIT Jamshedpur.
- A candidate will be allowed to take admission only if the medical certificate produced by the candidate is satisfactory.

12 Other Important Points

- Candidates are advised to visit the institute website regularly for updates (if any). No individual communication via postal or e-mail shall be made regarding selection process by the institute.
- Institute reserves the right to refuse admission to any candidate, or cancel the whole admission process, without assigning any reason.
- In the event of any information being found false or incorrect or incomplete or noneligibility being detected at any time before or after admission, his/her candidature is liable to rejection without further communication.
- An applicant once admitted in a particular postgraduate programme will not be allowed to shift to any other programme, even if seats remain available in other courses. However, if adequate number of students is not available in a particular programme, NIT Jamshedpur may not run that Programme. In such cases, a candidate

who has taken admission in that Programme may be allowed to change his/her admission to other M. Tech. Programme (even if the candidate has not applied for that Programme), where vacant seat is available in the respective categories and matches the qualifications of the candidate with the eligibility condition of that Programme.

• Students are required to observe prescribed Rules & Regulations and orders issued by the authorities from time to time.
